"On approval of the tariff and the tariff estimate in a simplified procedure on regulated services for gas transportation via the gas pipeline of Beineu-Shymkent Gas Pipeline Limited Liability Partnership"

In accordance with sub-item 1) of item 5 of Article 18 of the Law of the Republic of Kazakhstan dated July 9, 1998 "On natural monopolies and regulated markets", sub-item 7) of item 21 of the Regulation on the Agency of the Republic of Kazakhstan on regulation of natural monopolies approved by the Decree of the Government of the Republic of Kazakhstan No. 943 dated October 12, 2007, item 12, 13 and 16 of the Rules of approval of tariffs (prices, rates-fees) and tariff estimates in a simplified procedure, approved by the Order of the Chairman of the Agency of the Republic of Kazakhstan on Regulation of Natural Monopolies and Protection of Competition dated March 19, 2003 No. 80-ОД, based on the Decree of the Management Board of the Agency of the Republic of Kazakhstan on Regulation of Natural Monopolies No. 16 dated May 5, 2014, I ORDER:

- 1. To approve the tariff according to a simplified procedure for regulated services for transportation of gas via Beienu-Shymkent Main Gas Pipeline of Beineu-Shymkent Gas Pipeline Limited Liability Partnership to the amount of 11 765 KZT per 1000 m3 excluding VAT.
- 2. To approve the attached tariff estimate in a simplified procedure for regulated services for gas transportation via Beineu-Shymkent Main Gas Pipeline of Beineu-Shymkent Gas Pipeline Limited Liability Partnership
- 3. Beineu-Shymkent Gas Pipeline Limited Liability Partnership not later than six months after the approval of the tariff and tariff estimate in a simplified procedure shall provide the request for revision of the tariff and tariff estimates in a general procedure to the authorized body.
- 4. Administrative Department of the Agency of the Republic of Kazakhstan on Regulation of Natural Monopolies shall communicate this Order to Information Technologies and Information resources Protection Department of the

Agency of the Republic of Kazakhstan on regulation of natural monopolies and Beineu-Shymkent Gas Pipeline Limited Liability Partnership.

- 5. Supervision of this Order execution shall be assigned to Mr. A. Alpysbayev, Deputy Chairman of the Agency of the Republic of Kazakhstan on Regulation of Natural Monopolies.
- 6. This Order shall come into force from the date of signing except for items 1 and 2 of this Order, which entered into force on June 1, 2014.
